Consent for medical services and treatment

I further understand that if I enroll in another insurance plan, it is my responsibility to notify the office; or I will be responsible for non-covered payments due to inaccurate billing.

I understand there are fees related to failing to reschedule appointments or pay invoices in a timely manner.
